Once approved and permit issued, permit must be picked up and displayed in front window of residence to be valid. A permit not displayed on site will be subject to a violation for failure to follow the procedures.

Note: Stumps must be removed or flush cut and covered with mulch. All requested trees must be marked. Owner should verify contractor's property damage and liability insurance.

REQUEST FOR TREE REMOVAL

PROCESS REQUIREMENTS FOR REQUEST FOR TREE REMOVAL

1. The property owner must complete the Request Form.
2. Owner's signature must be notarized if not signed in person at the CPI Office.
3. Upon receipt of the signed request, an inspector will visit the property and determine the number of trees requested to be authorized for removal.
4. The inspector will mark the trees authorized for removal using a designated color paint.
5. No trees may be removed unless the permit is prominently displayed in the front window of the residence.

POTENTIAL PENALTIES FOR FAILURE TO ADHERE TO THE APPROVAL PROCESS REQUIREMENTS

1. Property owner will receive a violation notice from CPI Department.
2. Property owner will be given 15 days to contact the CPI Department to address the notice.
3. If the owner fails to address the notice by the end of 15 days, the violation will be forwarded to the Architectural Review Committee to address and recommend to send to the General Manager for further action, typically to be forwarded to the Association's attorney. At this time, the property owner will be subject to suspension of voting rights and the ability to use and belong to any of the Association's amenities until compliance requirements are met.
4. The Attorney will initiate the process of obtaining a court order to compel compliance upon receipt of the case.
