Photo Submission Guidelines:

- All required photos must be submitted as part of the application package.
- Photos should be in a digital format (JPEG or PNG) and of sufficient quality to clearly showcase your products and setup.
- The review committee will not accept referrals to external websites or social media platforms for photo review. All required photos must be included with the application submission.

Consequences of Incomplete Submissions:

Failure to provide the required photos with your application package will delay the review process. The review committee will not begin evaluating your application until all necessary photos have been received.
