#### **Prior Minutes**

- Application needs to be revised need more background on applicant.

- Applicant approval checklist would like to automate the process maybe thru DocuSign or something similar.
- Draft committee application advisory committee checklist.
- Changes to resolution C-01.
- Changes to each committee's webpage.

Doug spoke about the process of rejecting an applicant. Only the board of Directors can do this. Discussion ensued.

Next steps are to remove the word "reject" on the form. The form needs to be tweaked before implementation.

## Conduct and format of all committee meetings

All meetings are to follow "Roberts Rules of Order". Talked about video and storage of meetings. Only in discussion phase but looking to video all meetings and retain for 2 months.

#### Committee Reports

Aquatics Committee: no report.

ARC Committee: John Dilworth talked about needing guidance of counsel for advice on implementation of HB615.

Budget and Finance Committee: Dick Keiling talked about the following -

- Accomplished deep dive into the budget, met with DMA group concerning reserves and recommendations. He states that we needed to increase road reserves. This was accomplished and now we have a million in reserves for roads.
- Looking into MOU with Fire Department.
- Need for a formal capitol campaign for the Fire Department.
- Mailbox repairs are going forward.

Bylaws and Resolutions: Lora Pangratz noted the Committee has no requests presently and are behind on going over items due to the referendum. Committee goals are to continue review of the 33 resolutions and review M-09.

Communications Committee: Cheryl Jacobs talked about the following –

- Recommend a town hall to educate folks about all the things that are going on in OP.
- Need new "Vote" signs for the next election. Want to run a contest for the design of these signs.
- Family fun day?
- Working on the "Virtual Residence Academy" to capture the rich history of OP thru recording our founding residents.
- Electronic sign proposal at the Northgate bridge got a \$21,000 estimate.

Strategic Planning: Bernie McGorry stated the Committee developed first long-term strategic plan for Ocean Pines.

Election Committee: Tom Piatti talked about the following -

- In research phase right now.
- Contacted some companies to maybe outsource voting.
- Issue with companies that specialize in elections and voting not understanding how to do referendums (concerning short-term rentals) when taking into consideration all of our sections.

Environmental and Natural Assets: Sharon Santacroce talked about the following -

- Need educational signs for our trails and "Duck and Goose" crossing signs.
- Fishing events Cleaning up after them and having children coloring books during the event
- Vegetative buffers for erosion issues.
- Try to get some grant money for Canada Geese problem.

Golf Committee: Frank Brown talked about the following –

- Membership is up from 91 last year to 170 this year. They are focused on increasing membership.
- Make applications more readily available.
- New merchandise in the pro shop is on sale for the holidays.
- Course drainage system is working well. Also, air flow problems are being corrected.
- Raised over \$10,500 in scholarships. Pink Lady's donated \$2,500 to AGH, Toys for Tots generated 75 new toys for the needy. Three other tournaments raised over \$20,000 for other charities.

Marine Activities: David Allen talked about the following -

- Working on safety issues concerning docks.
- Encouraging canal residents to get 150 seed oysters for water filtration. Low cost and effective. Need to get the word out to our members about this.
- Talked about increasing bulkhead height going forward.
- Talked about getting solar lights for the OP bridges in canals.

Recreation and Parks: Bill Barnard talked about the following –

- Bike and pedestrian safety are a focus. Requesting additional crosswalks.
- Recreational trails make sure they are maintained. Need signs concerning where the trail goes.
- Kayak and Kayak launches ADA accessibility at Pintail Park.

Racquet Sports: Doug Parks read the report submitted by Susan Morris. In summary, the Committee wants to consolidate all 3 sports to one entity.

Search Committee: no report.
