Election Results Validation (By-Laws Sections 4.02(a) and (b): A discussion of election results validation/validate topic was conducted. The question becomes whether or not validating the results at the Annual Meeting requires a vote of the members present and, if there is not a quorum at the Annual Meeting, must the Board vote to validate the results at a special Board meeting. This included a review of how other HOA's and local municipalities finalize voting results. Also included in the discussion was a of By-Laws provisions that could be applied in reaching a recommendation regarding the meaning of validate in the By-Laws.

NEW BUSINESS:

M-01/M-10 First Reading: A first reading of resolutions involving the Resolution M-01 was held at the October 2 Board meeting. Because the Board meeting was just two days prior to this Committee meeting, there was insufficient time for the Committee to prepare a review of the first readings.
