## **Section 2. Section of Major Activities during Reporting Period 2021:**

- Continued manifold efforts to attempt to influence the resident Canada Goose population.
- Began DNA water quality to identify sources of pollution in the ponds
- Proposed test of specialized grass to deter resident geese
- Adaption of new informative "Don't feed the Geese" signs detailing the rationale why this harms the geese.
- Proposed the OPA management take over annual timely egg addling.
- Submitted a motion to allow a shrub and tall grass vegetation border around all ponds to virtually eliminate all resident geese.
- Working in conjunction with MCBP on the continuation of Bay Day.
- Began efforts with MCBP to environmentally optimize the route 90 pond for the benefit of the property holders as well as an provide incentive for ongoing stewardship.
- Alerted OPA management to certain potential property ownership concerns
- Continued promotion of mailbox pavilion design for beautification, including a current motion to move forward on 1 or 2 locations.

- Have begun an inquiry to determine if the 100' of our shoreline on the bay (next to Seacrets) has potential to be worthwhile amenity
- Published or contributed on two "Green Street" articles

### **Section 3. Problems Encountered and Assistance required:**

• We looked forward to more timely and direct communication from The Board and OPA management on items involving our committee in the future.

## Section 4. Request for items to be included in the next OPA budget:

- Necessary dollars for the continuation of the Wildlife management program.
- Costs to complete the installation of one, two, or more prototype mailbox pavilions.

### **Section 5. Recommendations for Board Action:**

The committee believes the Board of Directors and our management needs to take an active and ongoing role in the improvement of our water quality as it relates to our fragile environment, by working proactively together with the MCBP, and State programs. Engage with the MCBP to promote an employee of OPA being appointed to their Board.

- Continue our inquiries on: saving the shad, effluent spray potential beyond the golf course, clam propagation and seeding
