UNFINISHED BUSINESS

- South Pond Buffer/Erosion Plan Pricing/contract of March 10, 2023 from SOLitude Lake Management (John Phelps) was submitted to MCB for funding consideration through OP Management via Doug Parks.
- Interpretive Signs for Route 90 Pond Patty Gamby e-mailed committee members with her suggestions and asked for our feedback. She noted that Ad Art is potential contact for creating our signs. Also Tim made a call to Assateague Park and found they do not have any state or federal signs available for our use.
- Duck Crossing Signs Anne provided feedback that OP Management has ordered these signs. We await their arrival for use at roadways with excessive waterfowl crossings especially families with goslings and ducklings.
- Oyster Gardening Karen Baldwin and members discussed a potential video for educating school children about the importance of oysters in cleaning our waterways. Horseshoe crabs were also discussed and the important role they play in our ecosystem.
- Tree Removal & Permitting Process John sat in the lobby of Public Works to wait for someone to discuss the process. OP has a lack of inspectors to oversee tree removal and one or two of our members may volunteer to help out especially on weekends. Tim mentioned in the future possible new trees might be planted in parks to replenish the dying and aging trees (for our future radar).

- MD 90 Corridor Study John gave a review of the state's website outlining the prospective plans to widen the corridor and potential environmental impacts. He said there is an excellent article in the March 2nd Bayside Gazette that covers this topic in-depth. This project is 5 to 10 years away.
