Mr. and Mrs. Dwyer came in to talk about the need for a daycare home base business. They will modify the 2-door garage, they are going to be licensed with the State, with a maximum of 8 children but will probably only have 5-6 children. Hours of operation will be 6 a.m. to 6 p.m. Susan believes that this goes against the image of Ocean Pines. Mrs. Dwyer spoke to Ocean Pines Public Works, and they said they did not need a variance and this a permit is only needed. Mrs. Dwyer believes this home occupation falls under the Maryland state laws, it is not commercial, and that it should fall under the Home-Based Business permit. She believes that there is a need for this in this community. Susan made a motion to deny the request for the home-based business, Kevin seconded, and all were in favor.

<u>13 Frigate Run – Exception for a portion of the left side of a proposed play/pet enclosure to go over the side</u> BRL by approximately 4' (2' from property line):
